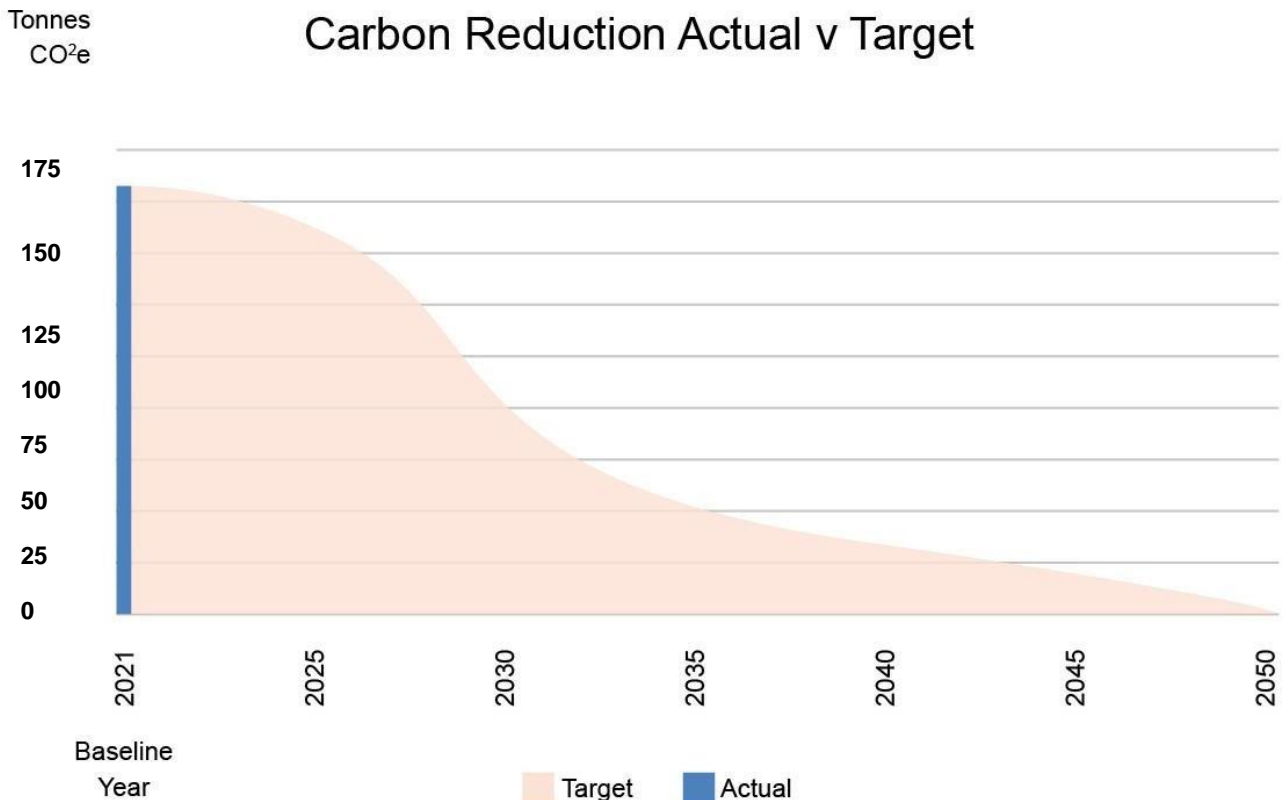

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. We project that carbon emissions will decrease to 83.02 tonnes CO₂e by 2030. This is a reduction of 50%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline.

- Formed an ESG working group with carbon reduction as a key area
- Achieved the ISO14001 Environmental Management Standard
- Achieved Carbon Literate status as an organisation (at bronze level) accredited by the Carbon Literacy Project
- Appointed Carbon Champions at our operational sites
- All employees are required to complete a mandatory environmental awareness e learning module

These measures will be in effect when performing the contract

In the future we will implement further measures including:

- Formulating a formal carbon management plan to deliver reductions and engage employees
- Implement a green travel plan and encouraging more employees to take up the ride to work scheme already in place and choose alternative methods of transport where possible
- Rolling out carbon literacy training to more employees
- Reviewing of our Scope 3 impacts for potential future inclusion
- Introduce more comprehensive environmental awareness training across the business
- Investigating credible carbon offset opportunities.
